Code Change: Parking- North Washington Street

The following wording may be used for legislation to amend the Village Code to allow for changes that will prohibit parking during certain hours in front of the Neighborhood House except for senior vans. It also will eliminate a prohibition currently in effect in that area.

Material to be deleted is in parenthesis. New material is set forth in capital letters.

291-80. Schedule XV: Parking Prohibited Certain Hours

In accordance with the provisions of 291-19, no person shall park a vehicle between the hours listed upon any of the following described streets or parts of streets:

(Washington Street North)	(West)	(12 noon to 4:30 p.m. Thursday)	(From a point 59 feet north of Wildey Street north for 30 feet)
WASHINGTON STREET, NORTH	WEST	9:00 A.M. TO 4:00 P.M. MONDAY THROUGH FRIDAY; EXCEPT FOR SENIOR VANS	FROM A POINT 60 FEET NORTH OF WILDEY STREET NORTH FOR 60 FEET
