BUDGET HEARING AND BUDGET ADOPTION RESOLUTIONS FISCAL YEAR 2020-2021

A. <u>VOTE BY THE BOARD TO CLOSE THE PUBLIC HEARING ON THE 2020-2021</u> <u>BUDGET</u>

Trustee Zollo moved, seconded by Trustee Rinaldi and unanimously carried, that the hearing be opened.

On the motion of Trustee Zollo, seconded by Trustee McGovern, and unanimously carried that the following resolution be approved: Yes 7; No 0; Abstain 0.

BE IT RESOLVED, that the Board of Trustees of the Village of Tarrytown does hereby close the public hearing on the 2020-2021 Tentative Village Budget originally opened on Monday, March 16, 2020.

B. <u>RESOLUTION TO DECLINE ADOPTION OF THE LOCAL LAW TO OVERRIDE THE 2% TAX CAP LIMITATION</u>

RESOLUTION TO DECLINE ADOPTION OF THE LOCAL LAW TO OVERRIDE THE 2% TAX CAP LIMITATION

On the motion of Trustee Hoyt, seconded by Trustee McGovern, and unanimously carried that the following resolution be rejected: Yes: 7; No: 0; Abstain: 0

Whereas, the Village of Tarrytown Board of Trustees, Village Administrator's Office and Village Treasurer's Office of the Village of Tarrytown, after introduction of the Tentative Village of Tarrytown Budget for Fiscal Year 6/1/2020 through 5/31/2021, have been monitoring the significant economic impacts of the COVID-19 Coronavirus; and

Whereas, a number of revenue streams are being significantly reduced due to the temporary closure or restriction of non-essential businesses, and the Village is seeing and projecting severe declines in revenues from Sales Tax, Hotel Tax, Parking revenues, Mortgage Tax and Building Permits, among others; and

Whereas, upon performing a review and amending the tentative Budget to include austerity measures, noting significant cuts in operating revenues and corresponding expenses, the Village Board and staff have been able to reduce the budget and the tax levy and at this time have determined it is not necessary to override the 2% tax cap limitation.

Whereas, the Board closed the public hearing on April 20, 2020 and directed that Village staff prepare the appropriate resolution for the Board's consideration.

NOW, THEREFORE BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown hereby determines that it is not necessary at this time to adopt a local law to override the 2% Tax levy limit established in General Municipal Law §3-c and withdraws the proposed local law, and directs the Village Clerk, Treasurer, and Administrator to take the necessary and appropriate actions to record that the village did not adopt the local law to override the 2% tax cap for Fiscal Year 2020-2021.

A RESOLUTION ADOPTING A BUDGET FOR THE FISCAL YEAR COMMENCING JUNE 1, 2020 AND ENDING MAY 31, 2021

On the motion of Trustee McGovern, seconded by Trustee Zollo, and unanimously carried that the following resolution be approved: Yes: 7; No: 0; Abstain: 0

WHEREAS, the Board of Trustees met on March 16 in the Board Room of the Village Hall, at 1 Depot Plaza, and on April 6 and April 20, 2020, at 8 p.m., via Zoom Video Conference, and heard all persons desiring to be heard thereon, and there was one person who attended and commented on the Tentative Budget; and

WHEREAS, during the budget process, changes were made to the budget, which are reflected in the Tentative Budget Amendment Resolution, which was adopted prior to this one.

NOW, THEREFORE, BE IT RESOLVED, that the Tentative Budget for Fiscal Year 2020-2021, as amended and set forth below, is hereby adopted and the Village Board of Trustees authorizes the appropriation of funding for the objects and purposes specified, including the amounts set forth required for the payment of principal and interest on indebtedness, in the following amounts:

E. FISCAL YEAR 2020-2021 TAX LEVY AND WARRANT

On the motion of Trustee Zollo, seconded by Trustee McGovern, and unanimously carried that the following resolution be approved: Yes: 7; No: 0; Abstain: 0

Roll Call – Trustee Zollo, Yes, Trustee McGovern, Yes, Trustee Brown, Yes, Trustee Butler, Yes, Trustee Hoyt, Yes, Trustee Rinaldi, Yes, Mayor Fixell, Yes.

WHEREAS, the budget for the fiscal year commencing June 1, 2020, has been duly adopted and filed with the Village Clerk, and it has been thereby determined that the sum of \$26,417,277 will be necessary to meet the obligations of the Village, and there has been duly credited against said sum estimated revenues and appropriated fund balance that total \$8,549,314 leaving \$17,867,963 to be raised by the property tax levy; and

WHEREAS, it appears from the Assessment Roll established in 2019 and updated in March, 2020 for taxes for the fiscal year June 1, 2020 through May 31, 2021 that the total assessed valuation of real property in the Village is \$2,153,947,713.

NOW THEREFORE BE IT RESOLVED that the tax rate for the Village of Tarrytown for the fiscal year commencing June 1, 2020 is fixed at the rate of \$8.2954 on each \$1,000 of assessed valuation for properties in the Village of Tarrytown.

BE IT FURTHER RESOLVED that the sum of \$17,867,963 shall be the taxes set for the fiscal year commencing June 1, 2020 and is hereby levied on the taxable property in the Village of Tarrytown and that the Village Treasurer and Receiver of Taxes is hereby authorized and directed to extend and carry out upon the roll the amount to be collected from each of the persons named thereon, and the respective amounts of said tax roll against each parcel of taxable property set forth thereon are hereby levied upon each parcel of taxable property respectively which said levy includes items shown on the budget for the fiscal year commencing June 1, 2020.

F. LEVY OF ADDITIONAL TAXES UPON TERMINATION OF EXEMPT STATUS:

On the motion of Trustee McGovern, seconded by Trustee Zollo, and unanimously carried that the following resolution be approved: Yes: 7; No: 0; Abstain: 0

BE IT RESOLVED that the Town Assessor and Village Receiver of Taxes during the fiscal year beginning June 1, 2020 are authorized to levy and collect additional Village taxes upon termination of exempt status of real property in accordance with provisions of Section 494 of the Real Property Tax Law.

Village Administrator Slingerland noted that the County Executive worked with the Town Supervisors and have decided that the County and Town taxes that are due by April 30, 2020, can be paid up to July 15, 2020, without penalty if taxpayers show a hardship. For example if the taxpayer was laid off or had to close down their business or show a similar hardship, they can file to pay their taxes late. If people pay late and do not show a hardship, they will be required to pay a reduced penalty. The town is responsible to administer the process and can decide which people would require certification.

This is only for County and Town taxes right now. This does not include School or Village taxes. The Village tax bills will be mailed out by May 31, 2020 and the taxpayers have until June 30, 2020 to pay without penalty.

Trustee Hoyt asked if the Village should consider waiving credit card fees for people to pay their tax bills by credit card. This would make it easier for the taxpayers, especially now that Village Hall is closed. Administrator Slingerland noted that they can pay either by mail or the Village has a drop box in the lobby of Village Hall. The Village can also arrange pickups with people on a case by case basis. Trustee Hoyt noted that is fine, but he wants to be sure that the seniors stay safe.
