PRESENT in person: Mayor Brown presiding; Trustees: Hoyt; McGovern; Mitchell and Rinaldi. Village Administrator Slingerland; Village Attorney Zalantis; Village Treasurer Morales; Village Clerk Gilligan and Deputy Clerk Fasman

REGULAR MEETING: 7:00 P.M.

The meeting began with the Pledge to the Flag.

BOARD MISCELLANEOUS AND LIAISON REPORTS

Mayor Brown reported that she has taken up the Mayors Challenge. The Mayors of the Rivertowns have taken on a friendly competition to see how many of our residents we can get to sign up for grid rewards. You can download an app on your phone and will receive notifications on how to earn rewards. Rewards are earned by lowering your thermostat, doing your laundry at different times and all things that can take the pressure off the grid, and a way to save money. Mayor Brown signed on not only because energy conservation is important, but also because the rates with Westchester Power did not quite work out so well this year as it has in years past. The Village remains committed to sustainable energy, and this is another way to do so. Additionally. Sustainable Westchester will be sending out a letter to all Town residents alerting them of the rate discrepancy and instructing them on how to opt out if they wish. Mayor Brown hopes everyone will sign up for the grid rewards program.

Deputy Mayor McGovern reported that the Egg hunt is this Saturday. She encourages people to walk or drop off as parking will be limited. Camp registration and pool memberships are now open and you can enroll online. If you are interested in becoming a Camp Counselor or Lifeguard information can be found on our website. In addition, a new yoga class will be starting April 17th. We have a beginner class as well as an intermediate/advanced class. Also, there are twenty two softball teams registered for the softball program. If you would like to put a team together, there is still time to enroll. Deputy Mayor McGovern concluded by stating that Pickleball will be starting up around the end of April. Additional information will be provided as it becomes available.

Trustee Mitchell inquired about a crosswalk on West Main Street. Administrator Slingerland replied that we have not accepted the final plans from the developer and we can further discuss this offline.

CHANGES AND/OR ADDITIONS TO THE AGENDA

There were no changes or additions to the agenda.

ADMINISTRATOR'S REPORT - UPDATE ON NY THRUWAY AUTHORITY BRIDGE PROJECT; REPORT ON CON EDISON ROAD CLOSURE OF NEPERAN ROAD ON FRIDAY, APRIL 7, 2023.

Administrator Slingerland reported that Treasurer Morales will be sharing report with the Board in terms of year to date revenues and expenses. Right now we are still running in the black, but a more comprehensive report will be shared with the Board in a few days. As for Village events, the Duck Derby is April 29th, and the Egg Hunt is this Saturday. Camp and Pool registration is open and please do not forget that proof of immunization is required to register. April is Earth Month and there are many events happening throughout the month. You can go to tarrytownenviro.org to see all of the events planned by TEAC, and Arbor Day is April 28th. We will be planting a tree at Patriots Park.

Administrator Slingerland continued by reporting that Con Edison will be working on Neperan Road on Friday the 7th, and there will be times that the road will be closed in both directions due to a utility pole repair. Administrator Slingerland also reported that Mayor Brown, Trustees Kim and Mitchell along with Chief Barbelet and himself met with the NYS Thruway Authority about the new Walkway that is going over 287. The Villages current water main goes under 287, and the new plan will extend the water main over the Route 9 Bridge as they are widening the road to accommodate six lanes of traffic. When completed, there will be a new traffic light at the intersection of Paulding and Broadway, and the light will be vehicle activated. Administrator Slinger then reported about the water pressure issues that homes in the Crest area have been experiencing. The Village is investigating this, and we have installed data logging equipment to monitor what is happening. We hope to have a meeting with the residents the week of April 17th and give them an update on what is happening. Administrator Slingerland concluded his report by talking about the turkey that has been sighted along Broadway the past few weeks. The Police Department was working with a couple trappers, and the turkey was briefly captured and then it escaped. It has not been causing problems lately at its regular location but if it comes back, we have trappers lined up and hopefully we can capture it and relocate it to a safer environment.

PUBLIC HEARING ON THE VILLAGE OF TARRYTOWN'S TENTATIVE BUDGET FOR FISCAL YEAR 2023-2024

The Public Hearing on the Tentative Budget FY 23-24 is continued and open for public comment, with the adoption of the Budget scheduled to take place on April 17, 2023.

A motion was made by Mayor Brown, and seconded Deputy Mayor McGovern to open the Public Hearing with all voting aye.

Administrator Slingerland noted that there was a round table discussion last week at the library and we heard from a number of residents who spoke about the budget. Dolf Beil brought up the fact that the Eastview Pump Station needs to be included in the budget as only the Eastview Dam was initially included. In the summation section of the Capital Projects line, there is a notation that is 'to be determined" because we do not know if we will get grants for these projects, and if we do how much grant money we will receive. The grant was submitted to the DEC and we have to complete some tests. We will keep in touch with them to see what else they might require. Administrator Slingerland continued his report by noting that the County's tax rate for Greenburgh residents for the sewer districts increased by 20.16% for your average homeowners and the County levy went down 4%. We will be discussing the budget again at the work session on April 12th, and if any changes are requested we will need them that evening. Once the budget is adopted, then tax rates can be set, and the tax bills will go out towards the end of May.

William Cerbone from Miller Ave. spoke about the Eastview Dam which he views as park land. He is concerned about maintaining all park land in the Village, and he cannot evaluate a two million dollar job on the Eastview Dam because he has no information. A FOIL request was submitted prior to the start of this meeting to get some more information. He requests this information be put on the Village website because this is the second time in a year that expenditures on park land have risen, the first being the Fireboat. In regards to the Fireboat, it's on our park land with a lease to tenant in which a subtenant who hasn't signed an agreement is going to Albany for funding on the basis of which our park land is our parks. How they were able to get to file with Albany for funding raises some concerns of the integrity of our park land. No we have a second one which is an enormous expenditure. He wants more information so that he can write a letter. Right now he is uninformed. Administrator Slingerland replied that the Village can share the letter form the DEC ordering us to do something about the dam and it included a report. This has been reviewed and options have been discussed over the past several years. The estimate of \$2.1 million was the number we came up with to submit with the federal grant application to see if we could get funding for remediation and rehabilitation of the dam. The key issue is that there is seepage through the dam, and we do not know the exact source. Mr. Cerbone replied that is more information that what we had at the library meeting. Mayor Brown noted that we will gather more information on whether the dam is considered park land or not.

On a motion made by Mayor Brown and seconded by Trustee Hoyt a motion was made to close to Public Hearing with all voting aye.

OPPORTUNITY FOR THE PUBLIC TO ADDRESS THE BOARD ON ITEMS NOT INCLUDED ON THE AGENDA. SPEAKERS HAVE THREE (3) MINUTES BEFORE YIELDING TO THE NEXT SPEAKER

Brad Schwartz an attorney from Zarin and Steinmetz addressed the Board of behalf of the owners of 303 South Broadway. This afternoon they submitted a rezoning petition to the Board that if approved would allow his clients to adaptively reuse the existing building at 303 South Broadway for residential use as the site is currently zoned OB and residential is not allowed. We are requesting an opportunity to appear formally before the Board at an

upcoming Work Session, make a full presentation and go through the details. Their client has been exploring for about a year on how to repurpose this underutilized building. Last year we came in with a grandiose plan that was not well received. We have spent a lot of time talking with staff and listening to feedback from the public, and went back to the drawing board. This new adaptive reuse design we think is consistent with the existing scale and height that exists today. We would add a partial fifth story on the roof that would be no higher than the existing mechanical room that exists today, and we think that there won't be a perceived difference than what is on the front of Broadway today or the six story apartments that are across the street. Visual materials were included in the packet that was presented today, and we are confident that we'll be able to demonstrate that there will not be an adverse visual impact with the additional fifth floor. On the site plan we submitted, the H shape remains, more greenery has been added, there's an opportunity to connect to the RiverWalk, and we can reclaim a portion of the parking lot for green open space and amenities for the residents. There are a lot of benefits that can be offered. Mr. Schwartz would like the opportunity to have a full conversation with the Board. The materials in the packet are still very conceptual and the architect is still working on the design. The new facade would result in environmental benefits in terms of energy efficiency and we believe it will be something everyone would be proud of. Mr. Schwartz concluded by requesting that this be placed on a formal agenda for a future work session so a more formal presentation can be made and hopefully engage in some meaningful dialogue.

ADJOURNMENT

There being no further business to come before the Board, the meeting was adjourned at 7:50 pm on a motion made by Mayor Brown, and seconded by Trustee Hoyt with all voting aye: 5-0
