The meeting began with the Pledge to the Flag.

Mayor Brown started the meeting with a moment of silence in honor of Louis Tucci Jr. a lifelong resident of Tarrytown who also worked for the Village and was a Life Active Member of the Tarrytown Fire Department.

## BOARD MISCELLANEOUS AND LIAISON REPORTS

Mayor Brown reported that June is Pride Month and she along with Trustee Rinaldi attended the raising of the Pride Flag in White Plains. It was a wonderful, inclusive event that recognized the LBGTQIA plus community We extend our support of that community, and everyone is welcome in this Village no matter who you are and who you love.

Trustee Mitchell reported that he attended a worship service in honor of the 137<sup>th</sup> Anniversary of the Shiloh Baptist Church. He had a great time there worshiping with the other parishioners, and he thanked the Shiloh Baptist Church for welcoming himself and Trustee Phillips-Staley with open arms.

Deputy Mayor McGovern reported that camp registration is now open. Camp will run from June 27<sup>th</sup> through August 19<sup>th</sup>. The pool is open, the fitness center is open, and the tennis programs are still going on.. The children's golf programs started today and will last for four weeks. ## CHANGES AND/OR ADDITIONS TO THE AGENDA

Administrator Slingerland noted there was an addition to the agenda which is a resolution for camp employee appointments as well as a number for the Village's liability insurance. We are tabling one resolution allowing pool memberships for Hastings on Hudson residents.

# ADMINISTRATOR'S REPORT

Administrator Slingerland reported that it is a very busy time of year in the Village with many events going on. We are also trying to fill several positions in the Village due to reassignments and retirements.

<u>PUBLIC HEARING – LOCAL LAW 6 TO AMEND CHAPTER 221, SECTION 5 OF THE</u> <u>TARRYTOWN CODE ENTITLED ALCOHOLIC BEVERAGES IN PARKS AND</u> <u>PUBLIC AREAS</u>

Deputy Mayor McGovern made a motion to open the Public Hearing which was seconded by Trustee Kim.

There were no speakers.

Deputy Mayor McGovern made a motion to close the Public Hearing which was seconded by Trustee Phillips-Staley.

On a motion made by Deputy Mayor McGovern and seconded by Trustee Mitchell the following resolution was unanimously approved with all voting aye. Approved: 5-0

Resolution to adopt Local Law 6-2022:

WHEREAS, a notice of public hearing of the proposed Local Law was published in the Journal News on May 19, 2022; and

WHEREAS, in consideration of said Local Law, a public hearing was held on the proposed action on June 6, 2022; and

WHEREAS, the Board of Trustees of the Village of Tarrytown is the only agency which has approval authority over the Proposed Action and is therefore the Lead Agency pursuant to the State Environmental Quality Review Act ("SEQRA") for the Proposed Action; and,

WHEREAS Chapter 221 of Village Code stipulates that alcoholic beverages can only be served, consumed or sold on Village property for events approved by the Board of Trustees; and

WHEREAS the Village has implemented a permit process for the Pierson Park Picnic Pavilion to streamline the approval of organized activities, provide for appropriate maintenance and staffing when needed, and ensure awareness of and adherence to park rules; and

WHEREAS Local Law 6 brings Chapter 221, Section 5 of the Tarrytown Code Entitled Alcoholic Beverages in Parks and Public Areas into conformity with current practice with the following changes:

Section 1. Be it enacted by the Board of Trustees of the Village of Tarrytown as follows.

**Section 2.** Former language revoked. Existing Parks and Recreation Areas Village Code section Chapter 221-5, entitled "Alcoholic beverages in parks and public areas" is hereby repealed in its entirety. Language repealed is as follows:

The consumption, sale or service of alcoholic beverages or the possession of any opened container containing any alcoholic beverage on any public property within the Village of Tarrytown is prohibited, except for organized activities approved in advance by the Board of Trustees. This section does not apply to the sale, service and consumption of alcoholic beverages at any licensed sidewalk cafe as set forth in Chapter <u>247</u>, § <u>247-6B</u> and <u>C</u>, of the Village Code.

**Section 3. Enacting New Article** - A new Chapter 221-5 entitled Alcoholic beverages in parks and public areas, is hereby adopted as follows:

- A. The consumption or service of alcoholic beverages or the possession of any open container containing any alcoholic beverage to persons of legal age in New York State is allowed within the Pierson Park picnic pavilion and the picnic pavilion lawn area, provided that a permit has been issued by the Tarrytown Recreation Department.
- B. The sale, service and consumption of alcoholic beverages on all public property within the Village of Tarrytown is prohibited, except for organized activities approved in advance by the Board of Trustees.
- C. This section does not apply to the sale, service and consumption of alcoholic beverages at any licensed sidewalk cafe as set forth in Chapter <u>247</u>, § <u>247-6B</u> and <u>C</u>, of the Village Code.

**Section 4. Severability.** If the provisions of any article, section, subsection, paragraph, subdivision or clause of this local law shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any article, section, subsection, paragraph, subdivision or clause of this local law.

**Section 5. Effective Date.** This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

NOW, THEREFORE, BE IT RESOLVED that in accordance with Article 8 of the State Environmental Conservation Law and 6NYCRR Part 617, including without limitations the criteria set forth in 6 NYCRR Part 617.7(c) and based upon review of the Proposed Action, the Village Board of Trustees hereby determines that the Proposed Action will not have a significant adverse impact on the environment, and hereby adopts a Negative Declaration.

BE IT FURTHER RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby adopt these changes as Local Law No. 6 of 2022.

OPPORTUNITY FOR THE PUBLIC TO ADDRESS THE BOARD ONLY ON ITEMS LISTED ON THE AGENDA, OTHER THAN PUBLIC HEARING ITEMS. SPEAKERS SHALL HAVE THREE (3) MINUTES EACH TO ADDRESS THE BOARD OF TRUSTEES.

#### SCHEDULE A PUBLIC HEARING- HACKLEY SCHOOL COMPATIBLE USE PERMIT

On a motion made by Trustee Mitchell and seconded by Deputy Mayor McGovern the following resolution was unanimously approved with all voting aye. Approved: 5-0

WHEREAS, the Hackley School submitted a site plan approval application for the demolition of the Zetkov Gymnasium and the existing Performing Arts Building and the construction of a new 54,000-sf Center for Creative Arts and Technology (CCAT) Building on property located within the unincorporated Town of Greenburgh; and

WHEREAS, the proposed construction will add 56 surface parking spaces and storm water management improvements on property located in the Village of Tarrytown; and

WHEREAS, after reviewing over the past year potential issues related to traffic, new events, water distribution and pressure, sidewalk connections, Steep Slopes narrative, lighting for parking lots and the CCAT building, pump house views, landscape buffering, location and availability for fire protection, storm water management, energy and sustainability, demolition and rock removal, as well as public comment on the project; the Planning Board recommends the approval of the site plan with a condition that the Applicant receive approval from the Village of Tarrytown Board of Trustees for an Amended Compatible Use Permit; and

WHEREAS, the Planning Board recommends that the Board of Trustees of the Village of Tarrytown approve the request for an Amended Compatible Use Permit based on a number of factors including that more building square footage will be removed than will be added with no increase in student enrollment or staff; the project is in compliance with Village zoning regulations; the project will not produce additional noise, fumes, vibration, lighting spillover or glare for nearby properties; the proposed parking areas are appropriately sized and buffered by landscape features; the new facility will not increase the density of the Village or add to the demand on municipal services; the proposed use for the new facility is harmonious with the current use of campus facilities; and the Hackley School will install a new sidewalk along Benedict Avenue to Midland Avenue to complete a gap in the sidewalk network and thereby improve pedestrian safety;

NOW THEREFORE BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby schedule a Public Hearing for the regular meeting of June 21, 2022, at 7:00 p.m., in the Municipal Building, One Depot Plaza, Tarrytown, New York, to hear and consider a Compatible Use Permit application for the Hackley School at 293 Benedict Avenue.

## **INSURANCE RENEWALS FOR LIABILITY AND WORKERS COMP**

WHEREAS, it is the recommendation of the Village Engineer that the bid be awarded to the lowest responsible bidder, Ferguson Water Works of New Hyde Park, NY per their bid of \$2,047,805.49.

## <u>RESOLUTION TO AUTHORIZE THE INSTALLATION OF A STOP SIGN AT MCKEEL</u> <u>AVENUE AND BEECH LANE</u>

Trustee Kim noted that on the upwards portion of McKeel Ave. where it intersects with Neperan there is a curve with diminished sightlines. The stop sign will help the pedestrian flow and the crosswalk will be repainted.

On a motion made by Deputy Mayor McGovern and seconded by Trustee Mitchell the following resolution was unanimously approved with all voting aye. Approved: 5-0

WHEREAS the intersection of McKeel Avenue, Beech Lane and Suncliff Drive is currently controlled by stop signs at three of the four approaches; and

WHEREAS the lack of a stop sign at the fourth approach resulted in complaints of confusion from drivers and pedestrians; and

WHEREAS in the last two five years two traffic accidents have occurred at the intersection, one involving a cyclist and a vehicle and the other involving two vehicles; and

WHEREAS the Traffic and Mobility Committee worked in collaboration with DTS Provident traffic engineers to analyze the intersection and make recommendations for safety improvements at the intersection; and

WHEREAS based on the analysis, the Traffic and Mobility Committee put forth a recommendation to the Board of Trustees of the Village of Tarrytown that a stop sign should be installed at the intersection of McKeel Avenue and Beech Lane.

NOW THEREFORE BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown authorizes the installation of a stop sign at the intersection of McKeel Avenue and Beech Lane; and

BE IT FURTHER RESOLVED that Chapter 291 Section 73 Schedule VIII of Village Code entitled Stop Intersections shall be amended to reflect the change.

WHEREAS, on May 4, 2022, the Village of Irvington received four (4) bids for the 2022 Road Milling and Paving project and are summarized in the minutes for the proposed work in the Village of Tarrytown; and

WHEREAS, in accordance with the contract, each partner municipality will separately authorize the Contract and be responsible for payment of services performed within their respective municipality and the quantities of work required directly to the contractor; and

WHEREAS, the paving and milling is planned to take place on Riverview Ave, Grove Street, Detmer Ave. Doris Lane and Benedict Avenue for a total estimated contract amount of \$868,000 based upon the unit prices contained in the bids.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Tarrytown does hereby authorize the award of the contract, for the work to be performed in the Village of Tarrytown, for the 2022 Milling and Paving Contract to Montesano Bros., Inc. of New Rochelle, NY for a total estimated contract amount of \$868,000 in accordance with their unit prices contained in their bid of May 4, 2022; and

BE IT FURTHER RESOLVED that the Board of Trustees authorizes and directs the Village Administrator to execute an agreement for this project with Montesano Bros. Inc.

#### <u>RESOLUTION AUTHORIZING THE MULTI-VILLAGE CURB INSTALLATION AND</u> <u>REPLACEMENT CONTRACT AWARD FOR 2022</u>

On a motion made by Deputy Mayor McGovern and seconded by Trustee Mitchell the following resolution was unanimously approved with all voting aye. Approved: 5-0

WHEREAS, the Village of Tarrytown, in a cooperative relationship with the Villages of Ardsley, Dobbs Ferry, Elmsford, Hastings and Irvington, with Hastings on Hudson taking the lead on the bid process and soliciting bids for the 2022 Curb Installation and Replacement Project; and

WHEREAS, on April 29, 2022, the Village of Hastings received three (3) bids for the 2022 Curb Installation and Replacement project and are summarized in the minutes for the proposed work in the Village of Tarrytown:

WHEREAS, in accordance with the contract, each partner municipality will separately authorize the Contract and be responsible for payment of services performed within their respective municipality and the quantities of work required directly to the contractor; and

WHEREAS, the curb installation and replacement is planned to take place on Riverview Ave, Grove Street, Detmer Ave, Doris Lane and Benedict Ave. and other areas based upon the budget with an estimated contract amount of \$164,000.

NOW, THEREFORE, BE IT RESOLVED, that the Village Board of Trustees of the Village of Tarrytown does hereby authorize the award of the contract, for the work to be performed in the Village of Tarrytown, for the 2022 Curb Installation and Repairs to Woodland Manor, LLC of Patterson NY for a total estimated contract amount of \$164,000 in accordance with their unit prices contained in their bid of April 29, 2022; and

BE IT FURTHER RESOLVED that the Board of Trustees does hereby authorize and direct the Village Administrator to execute an agreement for this project with Woodland Manor, LLC

#### RESOLUTION TO ENCOURAGE THE USE OF LOW-EMBODIED-CARBON CONCRETE IN MUNICIPAL INFRASTRUCTURE PROJECT

Trustee Kim noted that concrete throws off a lot of carbon dioxide into the atmosphere. By authorizing this resolution, the Village will try to utilize low embodied carbon concrete when doing projects throughput the Village. Low embodied carbon concrete has additional additives that reduces the amount of carbon dioxide released into the atmosphere.

On a motion made by Deputy Mayor McGovern and seconded by Trustee Kim the following resolution was unanimously approved with all voting aye. Approved: 5-0

WHEREAS the Village of Tarrytown is committed to implementing policies and undertaking measures to reduce its contribution to human caused climate change, including reducing greenhouse gas emissions; and

WHEREAS the construction of the built environment is a significant contributor to greenhouse gas emissions; and

WHEREAS concrete is the most widely used construction material in the world because of its low cost, strength, and durability, among other factors, and is a significant component of all building and infrastructure projects, including those of municipalities; and

WHEREAS, cement, the critical ingredient that gives the concrete its strength, is responsible for up to eight percent of the world's carbon dioxide emissions, mainly through a chemical process called calcination, as well as through the use of energy in production derived from the combustion of fossil fuels; and

WHEREAS low-embodied-carbon concrete is defined as concrete that has been verified, as measured by a Global Warming Potential (GWP) metric, to embody lower carbon emissions as compared to the baseline embodied carbon emissions of conventional concrete; and

WHEREAS lowering the embodied carbon emissions from concrete can be achieved through diverse methods and processes, including but not limited to: (A) using less cement in concrete mixes; (B) replacing or substituting cement with supplemental cementitious materials (SCMs) such as fly ash, blast furnace slag, or ground glass pozzolan; (C) using locally produced cement and other concrete components resulting in reduced emissions from transport; (D) the utilization and mineralization of carbon in concrete materials; and

WHEREAS the New York State Department of Transportation and the Westchester County Department of Planning have identified specifications for low-embodied-carbon concrete in public infrastructure projects, and in January 2022, the State of New York passed a law to establish a low-embodied-carbon procurement standard for concrete in public construction projects;

NOW THEREFORE BE IT RESOLVED that the Village of Tarrytown encourages, and will work to promote, the use of low embodied carbon concrete products in building and infrastructure projects involving concrete, where the utilization of low embodied carbon concrete does not significantly increase the costs of or delay project completion, and where utilization does not compromise either construction integrity or public safety.

# ACCEPTANCE OF DONATION TOWARDS POLLINATOR PLANTING

On a motion made by Deputy Mayor McGovern and seconded by Trustee Phillips-Staley the following resolution was unanimously approved with all voting aye. Approved: 5-0

BE IT RESOLVED that the Board of Trustees of the Village of Tarrytown hereby authorizes the acceptance of a cash donation of \$200.00 and additional plantings at an approximate value of \$825.00 made by John Stiloski towards the Village of Tarrytown's Pollinator Gardens.

#### OPPORTUNITY FOR THE PUBLIC TO ADDRESS THE BOARD ON ITEMS NOT INCLUDED ON THE AGENDA. SPEAKERS HAVE THREE (3) MINUTES BEFORE YIELDING TO THE NEXT SPEAKER

Tina Bellino asked if she could speak about on and off agenda items. The Board agreed. Ms. Bellino then spoke about the agenda item regarding drivers and the Fire Department. Ms. Bellino inquired if a driver crashed a vehicle that cost a million dollars, would that person still be allowed to drive if it caused injuries? The Board of Trustees asked her to clarify her question. Ms. Bellino asked that if a driver of a Village vehicle that was in the fire department caused an accident with injuries, would that person still be allowed to drive a million dollar vehicle? Mayor Brown replied that the fire department after going through their own procedures, puts together a list of recommendations and the Village rarely questions their recommendations because they are the professionals, and we are not. Administrator Slingerland stated that Ms. Bellino was referring to a specific accident in which an accident investigation was performed and everything was found to be accepted procedures and protocols. Ms. Bellino asked if there was further training after the driver had already caused an accident. Administrator Slingerland replied that Ms. Bellino was using the word caused which is not an accurate comment.

Ms. Bellino then addressed the Board and stated that the acquiescence from the Board to appease the anti-police sentiment in our Village was fostering the ability to destroy personal property such as a police appreciation banner on the WI fence less than one day after it was placed there. It was no major shock that the slasher was a Karen Brown supporter. Ms. Bellino has explained how the leadership from this Board sets a negative tone in the Village against those who serve and protect us. There are signs throughout the Village that state hate has no home here. Does that exclude the Police Department and give free reign to unnecessarily butcher a police banner? Three days of the Police Appreciation week were lost due to Mr. McKee's slashing of the sign which then needed to be replaced. Administrator Slingerland removed Jose's banners and also took down appreciation signs around the Village even though there were other signs that were expired. She hopes the hypocrisy of hating the police in a town where hate has no home is not lost on their constituents. She hopes that attending Jose's fundraiser after removing his banner and flags is seen for exactly what it is, political pandering. 1278 residents did not vote for anyone on this board. Ms. Bellino is addressing them now. You are paying someone \$300,000.00 in salary, benefits, personal car etc. to remove signs from fences. Your tax dollars are going towards furthering an agenda you do not agree with. While there is growing political polarization and distrust in government this board does nothing to dissuade that. They search for relevance and public adulation rather than using their positions to find common ground and building trust. Their insipid timber even creeps into our school district. The Board should consider how their stances affect the rest of this town and our students. Ms. Bellino has been approached publically about her support of the police, and no one wants the police peddling in their Rinaldi issued bicycles with their Rinaldi issued nerf guns.

Robert Wingate from North Broadway wished to echo the sentiments and appreciation of the Board of Trustees in regards to the Shiloh Baptist Church who have demonstrated significant leadership in the community over the years, especially in regards to the park at the bottom of the hill. Mr. Wingate learned in the past few years what the church has been working on, and some of its history. He appreciates the conversations he has had with Reverend Williams and looks forward to individually supporting this church and other churches as they advance on how to contribute back to the community. On another note, there will be a Juneteenth celebration in Irvington on Saturday, June 18<sup>th</sup> at the Main Street School. This will largely focus in the groundbreaking for a sculptor by a very well know black sculptor named Vinnie Bagwell which will commemorate the history of slavery in Irvington as well as the river

towns. In addition, Greenburgh Pride is holding its second annual rally in Dobbs Ferry on June 25<sup>th</sup>. We look forward to creating safe spaces and celebratory opportunities for the LGBTQ plus community.

Reverend Williams from the Shiloh Baptist Church thanked the Mayor for stopping by their celebration yesterday and giving her the opportunity to give a little history of the church. Reverend Williams also thanked Trustee Mitchell and Phillips-Staley for worshiping with them yesterday. Reverend Williams asked the Board who was in charge of Sykes Park. Mayor Brown replied that about 30 or 40 years ago, Tarrytown and Sleepy Hollow who share both Sykes Park and Patriots Park agreed that Sleepy Hollow would take care of Sykes Park, and Tarrytown would take care of Patriot's Park. Any inquires or ideas about Sykes Park need to go to Sleepy Hollow. Reverend Williams thanked the Board for the information.

<u>PUBLIC HEARING – LOCAL LAW 6 TO AMEND CHAPTER 221, SECTION 5 OF THE</u> <u>TARRYTOWN CODE ENTITLED ALCOHOLIC BEVERAGES IN PARKS AND</u> <u>PUBLIC AREAS</u>

Deputy Mayor McGovern made a motion to open the Public Hearing which was seconded by Trustee Kim.

There were no speakers.

Deputy Mayor McGovern made a motion to close the Public Hearing which was seconded by Trustee Phillips-Staley.

On a motion made by Deputy Mayor McGovern and seconded by Trustee Mitchell the following resolution was unanimously approved with all voting aye. Approved: 5-0

Resolution to adopt Local Law 6-2022:

WHEREAS, a notice of public hearing of the proposed Local Law was published in the Journal News on May 19, 2022; and

WHEREAS, in consideration of said Local Law, a public hearing was held on the proposed action on June 6, 2022; and

WHEREAS, the Board of Trustees of the Village of Tarrytown is the only agency which has approval authority over the Proposed Action and is therefore the Lead Agency pursuant to the State Environmental Quality Review Act ("SEQRA") for the Proposed Action; and,

WHEREAS Chapter 221 of Village Code stipulates that alcoholic beverages can only be served, consumed or sold on Village property for events approved by the Board of Trustees; and

WHEREAS the Village has implemented a permit process for the Pierson Park Picnic Pavilion to streamline the approval of organized activities, provide for appropriate maintenance and staffing when needed, and ensure awareness of and adherence to park rules; and

WHEREAS Local Law 6 brings Chapter 221, Section 5 of the Tarrytown Code Entitled Alcoholic Beverages in Parks and Public Areas into conformity with current practice with the following changes:

Section 1. Be it enacted by the Board of Trustees of the Village of Tarrytown as follows.

**Section 2.** Former language revoked. Existing Parks and Recreation Areas Village Code section Chapter 221-5, entitled "Alcoholic beverages in parks and public areas" is hereby repealed in its entirety. Language repealed is as follows:

The consumption, sale or service of alcoholic beverages or the possession of any opened container containing any alcoholic beverage on any public property within the Village of Tarrytown is prohibited, except for organized activities approved in advance by the Board of Trustees. This section does not apply to the sale, service and consumption of alcoholic beverages at any licensed sidewalk cafe as set forth in Chapter <u>247</u>, § <u>247-6B</u> and <u>C</u>, of the Village Code.

**Section 3. Enacting New Article** - A new Chapter 221-5 entitled Alcoholic beverages in parks and public areas, is hereby adopted as follows:

- A. The consumption or service of alcoholic beverages or the possession of any open container containing any alcoholic beverage to persons of legal age in New York State is allowed within the Pierson Park picnic pavilion and the picnic pavilion lawn area, provided that a permit has been issued by the Tarrytown Recreation Department.
- B. The sale, service and consumption of alcoholic beverages on all public property within the Village of Tarrytown is prohibited, except for organized activities approved in advance by the Board of Trustees.
- C. This section does not apply to the sale, service and consumption of alcoholic beverages at any licensed sidewalk cafe as set forth in Chapter <u>247</u>, § <u>247-6B</u> and <u>C</u>, of the Village Code.

**Section 4. Severability.** If the provisions of any article, section, subsection, paragraph, subdivision or clause of this local law shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any article, section, subsection, paragraph, subdivision or clause of this local law.

**Section 5. Effective Date.** This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

NOW, THEREFORE, BE IT RESOLVED that in accordance with Article 8 of the State Environmental Conservation Law and 6NYCRR Part 617, including without limitations the criteria set forth in 6 NYCRR Part 617.7(c) and based upon review of the Proposed Action, the Village Board of Trustees hereby determines that the Proposed Action will not have a significant adverse impact on the environment, and hereby adopts a Negative Declaration.

BE IT FURTHER RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby adopt these changes as Local Law No. 6 of 2022.

WHEREAS the Traffic and Mobility Committee worked in collaboration with DTS Provident traffic engineers to analyze the intersection and make recommendations for safety improvements at the intersection; and

WHEREAS based on the analysis, the Traffic and Mobility Committee put forth a recommendation to the Board of Trustees of the Village of Tarrytown that a stop sign should be installed at the intersection of McKeel Avenue and Beech Lane.

#### RESOLUTION TO ENCOURAGE THE USE OF LOW-EMBODIED-CARBON CONCRETE IN MUNICIPAL INFRASTRUCTURE PROJECT

Trustee Kim noted that concrete throws off a lot of carbon dioxide into the atmosphere. By authorizing this resolution, the Village will try to utilize low embodied carbon concrete when doing projects throughput the Village. Low embodied carbon concrete has additional additives that reduces the amount of carbon dioxide released into the atmosphere.

On a motion made by Deputy Mayor McGovern and seconded by Trustee Kim the following resolution was unanimously approved with all voting aye. Approved: 5-0

WHEREAS the Village of Tarrytown is committed to implementing policies and undertaking measures to reduce its contribution to human caused climate change, including reducing greenhouse gas emissions; and

WHEREAS the construction of the built environment is a significant contributor to greenhouse gas emissions; and

WHEREAS concrete is the most widely used construction material in the world because of its low cost, strength, and durability, among other factors, and is a significant component of all building and infrastructure projects, including those of municipalities; and

WHEREAS, cement, the critical ingredient that gives the concrete its strength, is responsible for up to eight percent of the world's carbon dioxide emissions, mainly through a chemical process called calcination, as well as through the use of energy in production derived from the combustion of fossil fuels; and

WHEREAS low-embodied-carbon concrete is defined as concrete that has been verified, as measured by a Global Warming Potential (GWP) metric, to embody lower carbon emissions as compared to the baseline embodied carbon emissions of conventional concrete; and

WHEREAS lowering the embodied carbon emissions from concrete can be achieved through diverse methods and processes, including but not limited to: (A) using less cement in concrete mixes; (B) replacing or substituting cement with supplemental cementitious materials (SCMs) such as fly ash, blast furnace slag, or ground glass pozzolan; (C) using locally produced cement and other concrete components resulting in reduced emissions from transport; (D) the utilization and mineralization of carbon in concrete materials; and

WHEREAS the New York State Department of Transportation and the Westchester County Department of Planning have identified specifications for low-embodied-carbon concrete in public infrastructure projects, and in January 2022, the State of New York passed a law to establish a low-embodied-carbon procurement standard for concrete in public construction projects;

NOW THEREFORE BE IT RESOLVED that the Village of Tarrytown encourages, and will work to promote, the use of low embodied carbon concrete products in building and infrastructure projects involving concrete, where the utilization of low embodied carbon concrete does not significantly increase the costs of or delay project completion, and where utilization does not compromise either construction integrity or public safety.

#### OPPORTUNITY FOR THE PUBLIC TO ADDRESS THE BOARD ON ITEMS NOT INCLUDED ON THE AGENDA. SPEAKERS HAVE THREE (3) MINUTES BEFORE YIELDING TO THE NEXT SPEAKER

Tina Bellino asked if she could speak about on and off agenda items. The Board agreed. Ms. Bellino then spoke about the agenda item regarding drivers and the Fire Department. Ms. Bellino inquired if a driver crashed a vehicle that cost a million dollars, would that person still be allowed to drive if it caused injuries? The Board of Trustees asked her to clarify her question. Ms. Bellino asked that if a driver of a Village vehicle that was in the fire department caused an accident with injuries, would that person still be allowed to drive a million dollar vehicle? Mayor Brown replied that the fire department after going through their own procedures, puts together a list of recommendations and the Village rarely questions their recommendations because they are the professionals, and we are not. Administrator Slingerland stated that Ms. Bellino was referring to a specific accident in which an accident investigation was performed and everything was found to be accepted procedures and protocols. Ms. Bellino asked if there was further training after the driver had already caused an accident. Administrator Slingerland replied that Ms. Bellino was using the word caused which is not an accurate comment.

Ms. Bellino then addressed the Board and stated that the acquiescence from the Board to appease the anti-police sentiment in our Village was fostering the ability to destroy personal property such as a police appreciation banner on the WI fence less than one day after it was placed there. It was no major shock that the slasher was a Karen Brown supporter. Ms. Bellino has explained how the leadership from this Board sets a negative tone in the Village against those who serve and protect us. There are signs throughout the Village that state hate has no home here. Does that exclude the Police Department and give free reign to unnecessarily butcher a police banner? Three days of the Police Appreciation week were lost due to Mr. McKee's slashing of the sign which then needed to be replaced. Administrator Slingerland removed Jose's banners and also took down appreciation signs around the Village even though there were other signs that were expired. She hopes the hypocrisy of hating the police in a town where hate has no home is not lost on their constituents. She hopes that attending Jose's fundraiser after removing his banner and flags is seen for exactly what it is, political pandering. 1278 residents did not vote for anyone on this board. Ms. Bellino is addressing them now. You are paying someone \$300,000.00 in salary, benefits, personal car etc. to remove signs from fences. Your tax dollars are going towards furthering an agenda you do not agree with. While there is growing political polarization and distrust in government this board does nothing to dissuade that. They search for relevance and public adulation rather than using their positions to find common ground and building trust. Their insipid timber even creeps into our school district. The Board should consider how their stances affect the rest of this town and our students. Ms. Bellino has been approached publically about her support of the police, and no one wants the police peddling in their Rinaldi issued bicycles with their Rinaldi issued nerf guns.

Robert Wingate from North Broadway wished to echo the sentiments and appreciation of the Board of Trustees in regards to the Shiloh Baptist Church who have demonstrated significant leadership in the community over the years, especially in regards to the park at the bottom of the hill. Mr. Wingate learned in the past few years what the church has been working on, and some of its history. He appreciates the conversations he has had with Reverend Williams and looks forward to individually supporting this church and other churches as they advance on how to contribute back to the community. On another note, there will be a Juneteenth celebration in Irvington on Saturday, June 18<sup>th</sup> at the Main Street School. This will largely focus in the groundbreaking for a sculptor by a very well know black sculptor named Vinnie Bagwell which will commemorate the history of slavery in Irvington as well as the river

towns. In addition, Greenburgh Pride is holding its second annual rally in Dobbs Ferry on June 25<sup>th</sup>. We look forward to creating safe spaces and celebratory opportunities for the LGBTQ plus community.

Reverend Williams from the Shiloh Baptist Church thanked the Mayor for stopping by their celebration yesterday and giving her the opportunity to give a little history of the church. Reverend Williams also thanked Trustee Mitchell and Phillips-Staley for worshiping with them yesterday. Reverend Williams asked the Board who was in charge of Sykes Park. Mayor Brown replied that about 30 or 40 years ago, Tarrytown and Sleepy Hollow who share both Sykes Park and Patriots Park agreed that Sleepy Hollow would take care of Sykes Park, and Tarrytown would take care of Patriot's Park. Any inquires or ideas about Sykes Park need to go to Sleepy Hollow. Reverend Williams thanked the Board for the information.

## ADJOURNMENT

On a motion made by Deputy Mayor McGovern and seconded by Trustee Mitchell, the meeting was adjourned to go into Executive Session at 7:54 pm.

<u>PUBLIC HEARING – LOCAL LAW 6 TO AMEND CHAPTER 221, SECTION 5 OF THE</u> <u>TARRYTOWN CODE ENTITLED ALCOHOLIC BEVERAGES IN PARKS AND</u> <u>PUBLIC AREAS</u>

Deputy Mayor McGovern made a motion to open the Public Hearing which was seconded by Trustee Kim.

There were no speakers.

Deputy Mayor McGovern made a motion to close the Public Hearing which was seconded by Trustee Phillips-Staley.

On a motion made by Deputy Mayor McGovern and seconded by Trustee Mitchell the following resolution was unanimously approved with all voting aye. Approved: 5-0

Resolution to adopt Local Law 6-2022:

WHEREAS, a notice of public hearing of the proposed Local Law was published in the Journal News on May 19, 2022; and

WHEREAS, in consideration of said Local Law, a public hearing was held on the proposed action on June 6, 2022; and

WHEREAS, the Board of Trustees of the Village of Tarrytown is the only agency which has approval authority over the Proposed Action and is therefore the Lead Agency pursuant to the State Environmental Quality Review Act ("SEQRA") for the Proposed Action; and,

WHEREAS Chapter 221 of Village Code stipulates that alcoholic beverages can only be served, consumed or sold on Village property for events approved by the Board of Trustees; and

WHEREAS the Village has implemented a permit process for the Pierson Park Picnic Pavilion to streamline the approval of organized activities, provide for appropriate maintenance and staffing when needed, and ensure awareness of and adherence to park rules; and

WHEREAS Local Law 6 brings Chapter 221, Section 5 of the Tarrytown Code Entitled Alcoholic Beverages in Parks and Public Areas into conformity with current practice with the following changes:

Section 1. Be it enacted by the Board of Trustees of the Village of Tarrytown as follows.

**Section 2.** Former language revoked. Existing Parks and Recreation Areas Village Code section Chapter 221-5, entitled "Alcoholic beverages in parks and public areas" is hereby repealed in its entirety. Language repealed is as follows:

The consumption, sale or service of alcoholic beverages or the possession of any opened container containing any alcoholic beverage on any public property within the Village of Tarrytown is prohibited, except for organized activities approved in advance by the Board of Trustees. This section does not apply to the sale, service and consumption of alcoholic beverages at any licensed sidewalk cafe as set forth in Chapter <u>247</u>, § <u>247-6B</u> and <u>C</u>, of the Village Code.

**Section 3. Enacting New Article** - A new Chapter 221-5 entitled Alcoholic beverages in parks and public areas, is hereby adopted as follows:

- A. The consumption or service of alcoholic beverages or the possession of any open container containing any alcoholic beverage to persons of legal age in New York State is allowed within the Pierson Park picnic pavilion and the picnic pavilion lawn area, provided that a permit has been issued by the Tarrytown Recreation Department.
- B. The sale, service and consumption of alcoholic beverages on all public property within the Village of Tarrytown is prohibited, except for organized activities approved in advance by the Board of Trustees.
- C. This section does not apply to the sale, service and consumption of alcoholic beverages at any licensed sidewalk cafe as set forth in Chapter <u>247</u>, § <u>247-6B</u> and <u>C</u>, of the Village Code.

**Section 4. Severability.** If the provisions of any article, section, subsection, paragraph, subdivision or clause of this local law shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any article, section, subsection, paragraph, subdivision or clause of this local law.

**Section 5. Effective Date.** This local law shall take effect immediately upon filing in the office of the New York State Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

NOW, THEREFORE, BE IT RESOLVED that in accordance with Article 8 of the State Environmental Conservation Law and 6NYCRR Part 617, including without limitations the criteria set forth in 6 NYCRR Part 617.7(c) and based upon review of the Proposed Action, the Village Board of Trustees hereby determines that the Proposed Action will not have a significant adverse impact on the environment, and hereby adopts a Negative Declaration.

BE IT FURTHER RESOLVED that the Board of Trustees of the Village of Tarrytown does hereby adopt these changes as Local Law No. 6 of 2022.

#### RESOLUTION TO ENCOURAGE THE USE OF LOW-EMBODIED-CARBON CONCRETE IN MUNICIPAL INFRASTRUCTURE PROJECT

Trustee Kim noted that concrete throws off a lot of carbon dioxide into the atmosphere. By authorizing this resolution, the Village will try to utilize low embodied carbon concrete when doing projects throughput the Village. Low embodied carbon concrete has additional additives that reduces the amount of carbon dioxide released into the atmosphere.

On a motion made by Deputy Mayor McGovern and seconded by Trustee Kim the following resolution was unanimously approved with all voting aye. Approved: 5-0

WHEREAS the Village of Tarrytown is committed to implementing policies and undertaking measures to reduce its contribution to human caused climate change, including reducing greenhouse gas emissions; and

WHEREAS the construction of the built environment is a significant contributor to greenhouse gas emissions; and

WHEREAS concrete is the most widely used construction material in the world because of its low cost, strength, and durability, among other factors, and is a significant component of all building and infrastructure projects, including those of municipalities; and

WHEREAS, cement, the critical ingredient that gives the concrete its strength, is responsible for up to eight percent of the world's carbon dioxide emissions, mainly through a chemical process called calcination, as well as through the use of energy in production derived from the combustion of fossil fuels; and

WHEREAS low-embodied-carbon concrete is defined as concrete that has been verified, as measured by a Global Warming Potential (GWP) metric, to embody lower carbon emissions as compared to the baseline embodied carbon emissions of conventional concrete; and

WHEREAS lowering the embodied carbon emissions from concrete can be achieved through diverse methods and processes, including but not limited to: (A) using less cement in concrete mixes; (B) replacing or substituting cement with supplemental cementitious materials (SCMs) such as fly ash, blast furnace slag, or ground glass pozzolan; (C) using locally produced cement and other concrete components resulting in reduced emissions from transport; (D) the utilization and mineralization of carbon in concrete materials; and

WHEREAS the New York State Department of Transportation and the Westchester County Department of Planning have identified specifications for low-embodied-carbon concrete in public infrastructure projects, and in January 2022, the State of New York passed a law to establish a low-embodied-carbon procurement standard for concrete in public construction projects;

NOW THEREFORE BE IT RESOLVED that the Village of Tarrytown encourages, and will work to promote, the use of low embodied carbon concrete products in building and infrastructure projects involving concrete, where the utilization of low embodied carbon concrete does not significantly increase the costs of or delay project completion, and where utilization does not compromise either construction integrity or public safety.

#### OPPORTUNITY FOR THE PUBLIC TO ADDRESS THE BOARD ON ITEMS NOT INCLUDED ON THE AGENDA. SPEAKERS HAVE THREE (3) MINUTES BEFORE YIELDING TO THE NEXT SPEAKER

Tina Bellino asked if she could speak about on and off agenda items. The Board agreed. Ms. Bellino then spoke about the agenda item regarding drivers and the Fire Department. Ms. Bellino inquired if a driver crashed a vehicle that cost a million dollars, would that person still be allowed to drive if it caused injuries? The Board of Trustees asked her to clarify her question. Ms. Bellino asked that if a driver of a Village vehicle that was in the fire department caused an accident with injuries, would that person still be allowed to drive a million dollar vehicle? Mayor Brown replied that the fire department after going through their own procedures, puts together a list of recommendations and the Village rarely questions their recommendations because they are the professionals, and we are not. Administrator Slingerland stated that Ms. Bellino was referring to a specific accident in which an accident investigation was performed and everything was found to be accepted procedures and protocols. Ms. Bellino asked if there was further training after the driver had already caused an accident. Administrator Slingerland replied that Ms. Bellino was using the word caused which is not an accurate comment.

Ms. Bellino then addressed the Board and stated that the acquiescence from the Board to appease the anti-police sentiment in our Village was fostering the ability to destroy personal property such as a police appreciation banner on the WI fence less than one day after it was placed there. It was no major shock that the slasher was a Karen Brown supporter. Ms. Bellino has explained how the leadership from this Board sets a negative tone in the Village against those who serve and protect us. There are signs throughout the Village that state hate has no home here. Does that exclude the Police Department and give free reign to unnecessarily butcher a police banner? Three days of the Police Appreciation week were lost due to Mr. McKee's slashing of the sign which then needed to be replaced. Administrator Slingerland removed Jose's banners and also took down appreciation signs around the Village even though there were other signs that were expired. She hopes the hypocrisy of hating the police in a town where hate has no home is not lost on their constituents. She hopes that attending Jose's fundraiser after removing his banner and flags is seen for exactly what it is, political pandering. 1278 residents did not vote for anyone on this board. Ms. Bellino is addressing them now. You are paying someone \$300,000.00 in salary, benefits, personal car etc. to remove signs from fences. Your tax dollars are going towards furthering an agenda you do not agree with. While there is growing political polarization and distrust in government this board does nothing to dissuade that. They search for relevance and public adulation rather than using their positions to find common ground and building trust. Their insipid timber even creeps into our school district. The Board should consider how their stances affect the rest of this town and our students. Ms. Bellino has been approached publically about her support of the police, and no one wants the police peddling in their Rinaldi issued bicycles with their Rinaldi issued nerf guns.

Robert Wingate from North Broadway wished to echo the sentiments and appreciation of the Board of Trustees in regards to the Shiloh Baptist Church who have demonstrated significant leadership in the community over the years, especially in regards to the park at the bottom of the hill. Mr. Wingate learned in the past few years what the church has been working on, and some of its history. He appreciates the conversations he has had with Reverend Williams and looks forward to individually supporting this church and other churches as they advance on how to contribute back to the community. On another note, there will be a Juneteenth celebration in Irvington on Saturday, June 18<sup>th</sup> at the Main Street School. This will largely focus in the groundbreaking for a sculptor by a very well know black sculptor named Vinnie Bagwell which will commemorate the history of slavery in Irvington as well as the river

towns. In addition, Greenburgh Pride is holding its second annual rally in Dobbs Ferry on June 25<sup>th</sup>. We look forward to creating safe spaces and celebratory opportunities for the LGBTQ plus community.

Reverend Williams from the Shiloh Baptist Church thanked the Mayor for stopping by their celebration yesterday and giving her the opportunity to give a little history of the church. Reverend Williams also thanked Trustee Mitchell and Phillips-Staley for worshiping with them yesterday. Reverend Williams asked the Board who was in charge of Sykes Park. Mayor Brown replied that about 30 or 40 years ago, Tarrytown and Sleepy Hollow who share both Sykes Park and Patriots Park agreed that Sleepy Hollow would take care of Sykes Park, and Tarrytown would take care of Patriot's Park. Any inquires or ideas about Sykes Park need to go to Sleepy Hollow. Reverend Williams thanked the Board for the information.

On a motion made by Deputy Mayor McGovern and seconded by Trustee Mitchell, the meeting was adjourned to go into Executive Session at 7:54 pm.
