ADMINISTRATOR'S REPORT

Administrator Slingerland reported on the following:

- The Village was able to open the Citibank parking lot this past Friday. He thanked Ivan Koraca for his help on Friday night to setup the lot for parking.
- The shutdowns of the Catskill Aqueduct Water are done for the time being. As soon as we know, we will inform everybody with the next shutdown dates.
- There has been a change to the Garbage Schedule, which will be effective Monday, January 7, 2019. Curbside garbage collection on the listed streets will change from Tuesday to Monday. The list is as follows: 88 Benedict Avenue, Birch Way, Heritage Court, Heritage Hill Lane, Leroy Avenue, Loh Avenue, Prospect Avenue, 144 South Broadway, 156 South Broadway, 194 South Broadway and South Grove Street. If anybody has any concerns, you can email the Administrator at rslingerland@tarrytowngov.com or the Superintendent of Public Works at hwessells@tarrytowngov.com. A letter will be delivered to every resident on these streets.
- The update on the Loh Park project is that the Village is finalizing the work behind the doctor's offices at 200 South Broadway and we are approaching the finish line.
- We had a conference call on Friday regarding the Cell Tower. The MTA committed that they will take down the Cell Tower Pole by Franklin Courts by the end of 2018. They also confirmed that they are moving the MTA Antenna off the pole and onto the Thruway Authority's pole that is located on the south side of the 287 Corridor. The antenna will be an attachment to an existing pole that has been there for a few years now.
